This statement on the use of cookies at grieggreen.com is intended to assist you as a visitor at Grieggreen.com to understand which Personal Data we collect, why we collect Personal Data, how Personal Data is being used by us and what rights you have as a user.

Grieg Green AS ("GG") uses cookies at Grieggreen.com. Cookies are small text files that are stored on your computer when loading a webpage. The cookies allow us to understand the behavior of users visiting our website, so that we can improve our user experience. The cookies also allow us to show you marketing for our products and services on websites and channels outside of Grieggreen.com.

GG is the Controller for the processing of Personal Data as described in this Statement on Use of Cookies.

1. PERSONAL DATA WE COLLECT

By visiting Grieggreen.com, we will be able to collect the following indirectly identifying personal Data about you, such as:

- IP adress,
- User name
- Usage statistics
- Usage patterns

2. LEGAL BASIS FOR PROCESSING PERSONAL DATA

Upon visiting Grieggreen.com, you agree that GG may place cookies and process Personal Data as described in this Statement, in accordance to The Electronic Communications Act (ekomloven) § 2-7 b.

You can withdraw your consent at any time by deleting saved cookies in the settings of your browser. All browsers make it possible to restrict the use of cookies or to disable them using the browser settings. Withdrawal of consent does not affect the lawfulness of treatment until the consent is withdrawn.

3. HOW WE USE THE PERSONAL DATA WE COLLECT

The Personal Data collected by Grieg Green are used for the following purposes:

3.1 Statistics and analysis

GG collects information about visitors at Grieggreen.com to compile statistics on how visitors use the website. The purpose is to improve and further develop the information services on our website. Examples of what the statistics provide answers to, are the number of users visiting different pages, how long the visit lasts, what websites users come from and what kind of browsers visitors are using. This information does not contain user-specific details.

4. OVERVIEW OF COOKIES

Below is an overview of the cookies used at Grieggreen.com. The table contains the name of the cookies, a description of the purpose, the name of the supplier and how long they are stored in the browser.

5. DISCLOSURE OF PERSONAL DATA TO THIRD PARTIES

Personal Data collected through cookies at Grieggreen.com is not disclosed to third parties. The services used at Grieggreen.com are provided by suppliers who are subject to data processing agreements and process Personal Data on instructions from GG.

6. YOUR RIGHTS

If GG processes personal data about you, you have the right to request access to the personal data for which GG is the controller for. You may also request correcting, erasure and restriction in the processing of personal data in accordance with applicable data privacy legislation.

If you are of the opinion that GG has failed to comply with your privacy rights, you are within your right to submit a complaint to the applicable data protection authority (Datatilsynet).
